Visitor Survey Prizes – Terms and Conditions

Four-night stay (Monday-Friday) in a camping pod for two adults at Braithwaite Village Camping and Caravanning Club Site

1) Promoter:

- a) The Promoter of this prize draw is The Camping and Caravanning Club, Greenfields House, Westwood Way, Coventry, CV4 8JH.

2) Prize draw period:

- a) Opens: 01/04/2026
- b) Closes: 30/10/2026
- c) Any entries received outside this period will not be considered.

3) Eligibility:

- a) Open to UK residents aged 21 or over.
- b) Only one entry per person is permitted. Multiple entries from the same individual will be disqualified.
- c) Employees of The Camping and Caravanning Club, their immediate family members, or anyone professionally associated with this promotion are not eligible to enter.

4) How to enter:

- a) Enter by participating in this survey and completing the opt in information.

5) Prize:

- a) There will be one winner
- b) The winner will receive a four-night stay (Monday-Friday) in a camping pod for two adults at Braithwaite Village Camping and Caravanning Club Site
- c) The stay must be booked and taken between 30/11/2026 and 01/04/2027. The booking excludes bank holidays and dates are subject to availability.
- d) Prizes are non-transferable and there are no cash alternatives in place of the stated prize. In the event the stated prize is unavailable, The Camping and Caravanning Club reserves the right to substitute it with an alternative prize of equal or greater value.

6) Winner selection and notification:

- a) The winner will be randomly selected from all eligible entries.
- b) The draw will take place within 10 working days after the closing date.
- c) The winner will be notified via the contact details provided within 15 working days of the draw date.
- d) If any winner is not able, for whatever reason, to accept a prize, or cannot be contacted within 15 working days of the draw date, The Camping and Caravanning Club reserves the right to award the prize to another entrant.
- e) The prize will be awarded within 30 days of the draw date unless otherwise stated. If delays occur, the winner will be informed, and an updated fulfilment timeline will be provided.

- a) The winner's name or social media handle may be announced on The Camping and Caravanning Club's platforms without further payment or permission. However, the Club will usually seek explicit permission before publishing any personal details, in line with best practice and data protection principles.
